# Charity—The Greatest Masonic Virtue?

This is the season of the year when Charity is inescapable. We are barraged by postal mail and email exhorting us to donate to a seemingly endless variety of causes, many of which we may never have heard of but which purchased our contact information from some other organization that sells it to make money. This seasonal occurrence shouldn't be surprising, since surveys indicate that people are most favorably inclined to donate during the November-December holiday period. And, of course, the end of the year brings the inevitable planning in anticipation of income tax filing.

But anyone affiliated with Freemasonry shouldn't be overly offended by charitable solicitations perhaps merely bemused—since, from our earliest associations with Freemasonry, we were taught the virtue of Charity (among many other virtues).

Masonic scholars such as Albert Pike (*Morals and Dogma*) and Albert Mackey (e.g., *Encyclopedia of Freemasonry*) cite Biblical references to Charity, particularly First Corinthians XIII, in which St. Paul asserts that in comparison to Faith and Hope, Charity is the greatest of the three. But we are also reminded that the concept of Charity is much broader than making donations to the poor and less fortunate. Together with other scholars such as John Wesley, we are informed that when the Bible was translated from Greek, the English word should have been Love, not Charity.

Freemasonry, of course, teaches the more expansive definition of Charity as Love. We are taught that even if we accept the more limited definition of Charity as making donations, we are to

practice Charity out of Love for our fellow man; not, for example, merely in anticipation of securing a deduction on our income tax form.

There is, of course, nothing wrong, and much right, about the income tax law that offers deductions for charitable contributions. If income tax law is to be used to encourage certain financial behaviors, the charitable deduction must certainly be one of the most worthy.

Our Lakewood Masonic Foundation, as with all other legitimate charities, offers the potential of a federal income (or estate) tax deduction to the extent permitted by law. (Neither our Operating Fund nor our Endowment Fund qualify, although we encourage donations to those Funds from people who don't need or want a tax deduction.)

In recent years federal tax law has been amended to create a new opportunity for IRA owners to make charitable donations directly from an IRA. Beginning in the year the owner turns 70-1/2, the owner must withdraw a certain minimum amount each year, known as the Required Minimum Distribution (RMD), which then becomes part of the owner's annual taxable income—EXCEPT, that a donation made directly from an IRA to a registered charity (such as our Lakewood Masonic Foundation) is counted as part of the RMD but NOT as taxable income. This special treatment may or may not be beneficial depending on the owner's tax bracket. As always you should consult your legal and tax advisors.

### **Appreciated Assets As One-Time Gifts**

With stock markets once again approaching their all-time highs, the opportunity to make gifts in the form of appreciated assets becomes more attractive to many donors.

There are various reasons to use appreciated assets to make one-time gifts to an organization such as The Lakewood Masonic Foundation. Chief among them are the sense of personal satisfaction you will achieve from making a special gift and the likely benefit you will receive from the unique tax breaks for this type of gift.

A gift of an appreciated asset often provides you with a greater tax benefit than a gift of cash. For example, a gift of appreciated stock that you have held for more than 12 months can be deducted at its current value if you itemize deductions, and you won't have to pay capital gains tax on the appreciated portion of your gift. As always, you are encouraged to consult with your legal and tax advisors before making a gift of this type.

There are two ways to use appreciated assets—such as stocks, bonds, mutual fund shares, real estate and insurance policies—to make a special gift. One option is to donate the asset outright, meaning that it would be transferred immediately from you to The Lakewood Masonic Foundation. Another option is to fund a lifetime income gift, which will provide you with income for your lifetime or for some other specified period of time. If you prefer to make a more straightforward gift, you may simply write a check using the form in our newsletter (see page 11), by responding to our letter appeals or by adding a donation to your annual dues.

You may designate your gift or bequest to be used for our historic preservation, educational or charitable purposes; split your gift among these purposes; or simply ask that your gift be devoted to our greatest need. All gifts, other than a small percentage spent for printing and mailing, are used for our stated purposes.

Your donation is a special way of showing your love for our Lakewood Masonic Family and for our historic home. Our 2016 Centennial is upon us, and we still have lots of catch-up maintenance to complete on our facilities.

While gifts and bequests may be directed to our Lakewood Masonic Foundation, our Lakewood Masonic Temple Endowment Fund or our Lakewood Masonic Temple Company Operating Fund, please note that only gifts and bequests to our Lakewood Masonic Foundation are deductible for federal income and estate taxes to the extent permitted by law. Gifts to our Endowment and Operating Funds are not deductible; but, depending on your tax situation, deductibility may not be an issue for you.

### Master's Message

Brethren.


